It only includes collisions that occurred on a highway, involved one or more vehicles and involved human death or personal injury that were notified to the Police within 30 days of occurrence. Data collection and release is governed by the Department for Transport. Plymouth and Torbay collisions are not included as they form their own unitary council areas.
